ODVN PREVENTION PROGRAMS INCLUDE THE OHIO MEN'S ACTION NETWORK (OHMAN) AND THE NEW PLAYBOOK, AN EVIDENCE-INFORMED SIGNATURE TRAINING. THESE PROGRAMS WORK TO TRANSFORM INDIVIDUALS AND COMMUNITIES TO BRING AN END TO DOMESTIC VIOLENCE. OVER THE LAST THREE YEARS, ODVN HAS WORKED WITH RESEARCHERS AT THE OHIO STATE UNIVERSITY TO IMPROVE SERVICES FOR SURVIVORS WITH PARTNER-INFLICTED BRAIN INJURIES (PIBI) AND ESTABLISHED THE CENTER ON PARTNER INFLICTED BRAIN INJURY. The tax benefits recognized in the financial statements from such a position are measured based on the largest benefit that has a greater than 50 percent likelihood of being realized upon ultimate settlement. The guidance on accounting for uncertainty in income taxes also addresses de-recognition, classification, interest and penalties on income taxes, and accounting in interim periods. On September 30, 2021 and 2020, there were no material unrecognized tax benefits identified or recorded as liabilities.
