THESE PROGRAMS SERVED MORE THAN 80,000 WOMEN, MEN AND CHILDREN IN 2022. OVDN IS THE LEADING RESOURCE FOR DOMESTIC VIOLENCE ISSUES IN OHIO AND IS A MEMBER OF THE NATIONAL NETWORK TO END DOMESTIC VIOLENCE (NNEDV).
