Advocates Celebrate Big Win for Survivors: Gov. DeWine's Budget Includes \$20M for DV Services

ODVN and its member programs are extremely grateful to Gov. Mike DeWine and Attorney General Dave Yost for including \$20 million for domestic violence services in their proposed budgets.

Now advocates must ensure the General Assembly agrees to keep the funding in the budget. More than 50 staff from ODVN and its member programs will gather at the Riffe Center for Advocacy Day on March 23. They will remind legislators that their programs have experienced severe service reductions since 2019 when most of their VOCA grants were cut by 60% or more.

New Housing Program Accepting Applications

\$1.87 Million Available to Help Rural Homeless Survivors

ODVN's new housing program, REACH 2.0, is accepting applications from survivors who are working with our member programs in Ohio's 80 rural counties. The HUD DV Bonus Rapid ReHousing grant will provide at least 6 months of rental assistance for at least 231 survivors and children in its first year.
