



Regional Recovery Services Coordinator

Full time Exempt Position

Job Description

It is the responsibility of every ODVN employee to uphold the mission and purpose of this agency. The Ohio Domestic Violence Network advances the principle that all people have the right to an oppression-free and violence-free life; fosters change in our economic, social and political systems and brings leadership, expertise and best practices to community programs.

In addition, it is expected that all staff will communicate ethically and engage in providing excellent customer service. It is also an expectation that on the individual level, all staff members will work to further their personal capacity to foster a work culture based on the vision, purpose and values of our organization.

This job description defines areas for which an individual has primary responsibility and is not intended to limit the scope of the job in any way.

Summary

The Regional Recovery Services Coordinator will work with domestic violence (DV) programs, substance use treatment and healthcare providers, drug courts and other criminal/legal system services to ensure that substance-using survivors are receiving trauma-informed care and that barriers to successful movement through these systems are reduced or eliminated.

This position is funded by a non-renewing OneOhio Recovery Foundation grant to support substance use and recovery services. The current grant award period is 4/1/2025 to 3/31/2027.

Essential Functions Include:

- Develop training content, training plan, and facilitate training content for behavioral health providers on domestic violence dynamics, substance use coercion, the intersection of domestic violence and substance use, traumatic stress and trauma-informed approaches, and the impact of domestic violence.
- Collaborate with domestic violence program staff to identify the barriers domestic violence survivors face within behavioral health, healthcare, and criminal justice systems
- Establish accessible recovery support services and peer support availability within DV programs, behavioral health and healthcare providers, and the criminal justice systems that align with a trauma-informed approach. This includes laying the foundation for DV programs to provide peer support specialists funded by Medicaid.
- Increase collaboration among systems to ensure that survivors can successfully achieve independence and recovery from substance dependence.
- Develop standardized referral processes and pathways to recovery support for domestic violence victims.

- Assist in developing educational materials and resources addressing the intersection between domestic violence, substance use, and mental health
- Collect data on project progress and success in accordance with the grant requirements
- The Regional Recovery Services Coordinator will report to the Substance Use/Mental Health Program Director

Key Competencies and Requirements

- Must reside in Ohio with a strong preference for residents of Ashtabula, Geauga, Lake or Portage counties.
- The ideal candidate will have a degree in social work or clinical counseling and chemical dependency licensure. Preference will be given to candidates with clinical licensure.
- Experience working with survivors and people experiencing substance use and mental health issues.
- Experience developing and facilitating training.
- Experience providing consultation, technical assistance or customized support to individuals and agencies is a plus.
- Demonstrated strong organizational, communication and writing skills.
- Demonstrated ability to manage multiple tasks and deadlines and work independently.
- The willingness and ability to travel between and within the following counties: Ashtabula, Lake, Geauga, and Portage in the state of Ohio.
- The willingness and ability to travel to Columbus, Ohio is required on a regular basis.
- A valid Ohio driver's license.

Compensation: ODVN offers highly competitive salaries based on experience, a generous benefits package including partially paid health insurance for employees and their children; life insurance and short term and long term disability; other health insurance policies at low costs to employees such as dental and vision; Health Savings Account, up to 9% retirement plan contributions after one year of employment; and a generous and flexible accrued paid time off benefit.

The annual salary for this position will begin at \$50,000 depending on experience.
